## SUMMARY

Werner KIRCHERT, Obersturmbannfuehrer in the Waffen-SS, was in Slovakia with Einsatzgruppe H from the middle of November 1944 until January 1945. There he administered inoculations and made a long study of the health conditions in that unit. He was once in Pressburg and from there went to Trentschin, Neustadt, Dubnitz and Sillen in that order. During this period his immediate superior was GRAWITZ, SS Reichsarzt and Chief of Sanitation. Obersturmfuehrer HOEFFLE was German Military Commander of Slovakia. The commanders of Einsatzgruppe H belonged to the Reichssicherheitshauptamt. Non-commissioned officers and men were mostly Letts and Lithuanians.

Subject knows nothing of a revolt in Slovakia at this time. However he tells of an SS unit of 800 men, commanded by Standarten-fuehrer HARUN AL RASHID and later by ALIMOFF, which went over to the partisans on Christmas 1944. This unit was allegedly Arabian and was posted near Wag-Neustadt. An attempt was made to capture HARUN AL RASHID; however, it was not successful. Subject did not know ALIMOFF. He only saw a picture of him once, wearing a Russ ian medal, the Order of XLenin. ALIMOFF first fought in the Russian Army, then went over to the German side, and finally went back to the Russian side.

KIRCHERT states that he has not heard of Gruppenfuehrer BERGER playing any part in a revolution. Subject knows that the Dirlewanger Brigade was at Wagtale for about 2 or 3 weeks. Divisions-General HOECKER was their commander at the time. It was well known that the Dirlewanger Brigade committed many offenses against property.
