SUMMARY:

Subject states that the Orgazit was a GMBH and that he joined the firm in 1937 at the urgent request of the parent organization, the chemical factory Buckau. The chemical factory Buckau was formerly the firm Goldschmidt in Essen. At that time there were two installations at the Orgazit; the so-called A installation and the B installation. The A and the B installations in Ammendorf were kept separate. In addition, an Ethylen-Oxide installation had been built in Ammendorf; however, production had not yet started. The latter was managed by informant while, at the beginning, the Auer-gesellschaft was in charge of the B installation.

MOELLNEY asserts that operation of the A installation was begun and that the Ethylen-Oxide there produced was delivered to the IG.Orgazit was entirely responsible to OKH. The IG supplied the Orgazit with personnel. Informant points out that he became manager in 1941. As far as MOELLNEY knows, the Auer-gesellschaft's B installation manufacturing poison gas was tested in 1938. Subject states that AMEROS visited the plants.
